**NOTIFICATION**

**Subject :-** Admission of children belonging to weaker section and disadvantaged group in the neighborhood.

In continuation of this Department Notification of even no. dated 29-11-2011 it is hereby ordered that the schools receiving an aid or grants to meet whole or part of the expenses from the State Government or any Local Authority shall also be under obligation to admit in Class- I, to the extent of at least twenty five percent of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory education till completion as per provision made under Section -12 (1)(b) of the Right of Children to Free and Compulsory Education Act, 2009.

- 2) All Govt. aided schools as above functioning in the State should strictly follow this instruction
- 3) This order shall have immediate effect.


