NOTIFICATION

**Subject :- Adoption of criteria/norms for upgradation of Primary School to Upper Primary School/upgradation of Upper Primary School to High School and upgradation of High School to Higher Secondary School in the State of Tripura.**

The existing criteria/norms for upgradation of Primary School to Upper Primary School/ Upgradation of Upper Primary School to High School and upgradation of High School to Higher Secondary School including those receiving grant-in-aid from the Government have been reviewed by the high power committee constituted by the Government for preparing approach paper and action plan for implementation of Rastriya Madhyamik Siksha Abhiyan keeping in view the current socio- economic contexts and topographical features of the state.

In consideration of all aspects, a revised criteria/norms for upgradation of schools as above has been accepted by the committee concerned with an aim to ensure easy access to Schooling facilities to those aspiring for education at school level.

It has, therefore, been decided that the norms as accepted by the committee shall stand adopted **with immediate effect** in supersession of all orders issued earlier in this regard.

The criteria/norms to be pursued are indicated below :

**For Up-gradation to Upper-Pry School :**

i)	Population of the School area in case of plain area	: 1,000
ii)	Population of the School area in case of hilly area	: 500
iii)	Enrolment in terminal class (class-V) of feeder primary schools/section (Plain areas)	: 20
iv)	Enrolment in terminal class (class-V) of feeder primary schools/section (Hilly areas)	: 15
v)	Distance of the nearest Upper-Pry School from the existing primary school proposed for up-gradation to Upper-Pry school.	: 2 km.

**For Up-gradation to Secondary Schools :**

i)	Population of the School area in case of plain area	: 5,000
ii)	Population of the School area in case of hilly area	: 3,000
iii)	Enrolment in terminal class (class-VIII) of feeder Upper-Pry schools/section (Plain areas)	: 25
iv)	Enrolment in terminal class (class-VIII) of feeder Upper-Pry schools/section (Hilly areas)	: 15
v)	Distance of the nearest Secondary School from the existing Upper-Pry school proposed for up-gradation to Secondary school.	: 3 km.

<b><u>For Up-gradation to Higher Secondary (+2 stage) Schools :</u></b>		<b><u>Norms</u></b>
i)	Population of the School area in case of plain area :	10,000
ii)	Population of the School area in case of hilly area :	4,000
iii)	Enrolment in terminal class (class-X) of feeder Secondary schools/section (Plain areas) :	30
iv)	Enrolment in terminal class (class-X) of feeder Secondary school/section (Hilly areas) :	20
v)	Distance of the nearest H.S.(+2) School from the existing Secondary school proposed for up-gradation to H.S.(+2) School. :	4 km.
