**SUBJECT:- Constitution of an Expert team for Inspection of Evaluated Answer Scripts of Madhyamik Examination, 2019.**

Sir,

I would like to inform you that there are many complaint and Grievances about the evaluation of answer scripts of Madhyamik Examination conducted by Tripura Board of Secondary Education. There are many instances that the marks obtained by the candidates are changed after review/self-inspection and that the matter has come to the knowledge of the authority of the School Education Department and the authorities are also very concerned about the matter.

In view of the above it has been decided to constitute Expert teams consisting of 3 teachers per subject from DIET faculties and HMs/subject teachers to go to TBSE office and examine at least 200 answer scripts randomly and then give a report on measures to improve.

As such, I am directed to request you to make necessary step for formation of an Expert Committee.

The functions of the Committee:-

1. The team members shall visit to Tripura Board of Secondary Education & make an inspection of evaluated answer scripts of Madhyamik Examination, 2019 on random basis without knowing roll no. or name of student.
2. The team shall ensure accuracy of checking of answer sheets evaluated by the examiners.
3. The team members will analyse the setting of quality question papers and they will also assess whether is it evoking thought, is balanced, is clear etc. or rote memorization heavy, unbalanced, confused.
4. They shall analyse the marking system, scrutiny of answer scripts & recording.
5. The team shall analyse on the following points to take remedial measures:-
  - a) Whether changes are necessary in teaching pedagogy in any particular topics.
  - b) Whether teacher training is needed for any topic.
  - c) If any additional inputs or academic materials is needed for any topics.
6. They shall also suggest corrective measures to undertake in future in respect of any discrepancies/mistakes found during their inspection of answer scripts.
