

**Subject:-** Permission to Sri Arjun Namasudra, Group-“D” Staff of North Nalichara High School (deputed at Kulai Colony High School), Ambassa, Dhalai Tripura for rejoining in the service within 30<sup>th</sup> September, 2022.

Sri Arjun Namasudra was appointed as a Group-“D”staff on 06-07-2002 and he has been remaining absent from duties w.e.f. 07-11-2019 to till date in an unauthorized manner, which is against the provision of TSCS (Leave) Rules, 1986.

Sri Arjun Namasudra, Group-“D” Staff was given several opportunity to resume his duty, but he did not complied. Thereafter, he was directed to explain within 06<sup>th</sup> August, 2022 as to why he shall not be deemed to have resigned from Govt. service by invoking the provisions of the TSCS (Leave) (11<sup>th</sup> Amendment) Rules, 2013 i.e. Notification No. F.1(1)-FIN(G)/86, dated 20-06-2013 of the Finance Deptt.& Memorandum No.F.20(1)-GA(P&T)/18(Part), dated 12-12-2018 of the General Administration (Personnel & Training) Deptt. for remaining unauthorized absent for more than 01 (one) year at a stretch (w.e.f. 07-11-2019 to till date), failing which termination order will be issued accordingly from this end. In compliance to this, he has submitted a written representation vide letter dated, 21-07-2022. After scrutinizing the representation, he was called for personal hearing on 08-09-2022. Accordingly, he was appeared and also furnished a written representation. Considering the facts & circumstances, the undersigned pleased to give him the last chance to resume his duty.

Now, therefore, Sri Arjun Namasudra, Group-“D” Staff is hereby permitted to join duty with a condition for maintaining regularity at his deputed place of posting at Kulai Colony High School, Ambassa, Dhalai Tripura **on or before 30<sup>th</sup> September, 2022**, without prejudice to the action to be taken against him for remaining absent from duty unauthorizedly, failing which it will be presumed that he is unwilling to be retained in Govt. service and after expiry of the stipulated period i.e., 30<sup>th</sup> September, 2022, decision will be taken as per F.D's Notification No. F.1(1)-FIN(G)/86, dated 20-06-2013.
