No.F.1(1-8)SE/E(NG)/2017(L) dated 17/04/2017 respectively against the posts created on fixed pay basis Keeping in abeyance of the posts on regular pay scale vide No.F.8(1-26)-SE/PLAN/2016(15) dated 29/06/16, No.F.8(1-26)-SE/PLAN/2015(5) dated 29/06/15, No.F.8(1-26)-SE/PLAN/2016(10) dated 29/06/16, No.F.8(1-26)-SE/PLAN/2015(76) dated 19/01/16 & No.F.8(1-26)-SE/PLAN/2015(123) dated 30/05/16 with the concurrence of the Finance Department, Govt. of Tripura Vide Memo No.F.10(2)-FIN(G)/2005/PART-1 dated 11/01/16, No.F.10(2)-FIN(G)/2005/PART-1 dated 22/07/16, U.O.No.F.236/FIN(Edn.Cell)/2016 dated 04/01/16, U.O.No.F.110/FIN(Edn.Cell)/2016 dated 22/06/16 & U.O.No.F.149/FIN(Edn.Cell)/2016 dated 18/07/16.

Accordingly, they have joined their service as L.D. Clerk on the dates as mentioned in Col. No. 3 & have completed 5 years continuous service & eligible for regular pay scale from the date as mentioned in Col. No. 4. Their name has also been entered in data base of Finance Department against Sl. No. 24827, 24829, 24838, 24841 & 24842 respectively. Now, they are hereby allowed the regular Scale of pay of Rs.21,400/- (Twenty one thousand four hundred) only per month plus other admissible allowances in the level -7 of Tripura State Pay Matrix of 2018 as per Memo. of the Finance Department, Govt. of Tripura vide No.F.10(2) FIN(G)/05/part-1 dated 16/10/2007.


The expenditure involved for this purpose is debitable to the Head of Account against which their fixed pay are being drawn at present.


