Subject :- Re-allocation of fund for Re-imburement of Madhyamik Examination fee to the various DDO(s) during the financial year 2019-20 under Revenue Head against TSP (Demand No. – 19).

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2015/16965 dated 22/10/2019 has released a fund of ₹16,00,000/- only under **F.R. Code No. 2089** being the Stipend & Scholarship (Non-Salary) during the financial year 2019-20 under revenue head **against TSP (Demand No. 19)**.

Now, after careful consideration of the requirement a sum of ₹9,80/- (**Rupees nine hundred eighty**) only being the **Re-imburement of Madhyamik Examination fee during the financial year 2019-20** is hereby re-allocated to the various H/O & D.D.O **West District** under Revenue head against **TSP (Demand No.-19)**.
