MEMORANDUM

Subject: - Introduction of Online Portal for Privately Managed Un-Aided Schools to apply for opening, New Registration of Play School, Elementary School under RTE & for No Objection Certificate for setting up CBSE school.

There are about 138 nos. of independent JB, 101 nos. of SB, 78 nos. of High & 32 nos. of HS Privately Managed Schools presently running under Education [School] Department in the State of Tripura.


The School Education Department has been regularly receiving applications from the Privately Managed School authorities for New Registration of Elementary School and for issuing of No Objection Certificate for setting up CBSE school. Moreover applications for establishment of Play Schools and new Primary Schools are also being received every now and then. All the above activities are being done offline till today.

For easy and smooth implementation of the aforesaid functions, the State Government has decided to introduce an online portal through which the Privately Managed School by fulfilling the terms and conditions as laid down in the department's Memo vide No. F.11(7-59)-DSE/93 Dated, 24th December, 1999 (Copy enclosed) interested to establish New Play School/ Elementary School in the State, will have to apply online through the newly launched web portal. Further, the Privately Managed School authorities willing/ intending to obtain NOC for setting up CBSE school will also have to apply online. The date of making the services live shall be from 15th March, 2021, no physical/ manual application is/ will be required in addition to online application from that date.

It has, therefore, been decided by the Government of Tripura that online submission of application for the aforesaid purposes will commence from 15th March, 2021 for the **Academic Session 2021-2022**. The concerned Principal/ Headmaster of the intending Privately Managed school may apply online by clicking on the attached web portal <https://edistrict.tripura.gov.in> for-


- (i) Opening of Play school/ Primary School,
