
**Sub: Filling up of Forms for TBSE annual Board Examinations**

Tripura Board of Secondary Education has notified the schedule for filling up of forms for Madhyamik and Higher Secondary Examinations 2021 vide, No.F.2(22)-TBSE/ADV/2018 Dated, 10<sup>th</sup> November, 2020. As per this notification the time given for completion of the entire process is from 12<sup>th</sup> January 2021 to 27<sup>th</sup> January 2021.

In this regard the following are reiterated for strict compliance by all the schools affiliated to TBSE.


1. All the students enrolled in Class X and Class XII shall fill up forms for appearing in the Madhyamik and Higher Secondary (+2) Examinations respectively within the given time schedule. No students shall be disallowed from filling up the forms or held back from appearing in the Board Examinations conducted by TBSE due to not having requisite percentage of class attendance, not obtaining requisite pass percentage or non-appearance in Pre-Board Examinations.
2. There will be no internal marks allotted against class attendance during the current academic session and so there will be no minimum attendance requirement for appearing in the Board Examinations, 2021. However, it may be noted that a weightage in internal assessment marks will be allotted from the performance in Pre-Board Examination. If a student does not appear in the Pre-Board Examination, he/she will not be given any marks for that portion of internal assessment against Pre-Board Examination, but she/he will be allowed to appear in the Board Examination.
3. A separate circular will be issued by TBSE in detail on allotment of internal assessment marks which will be applicable for the current academic session (2020-21) only in view of the ongoing COVID-19 pandemic.

This is for strict compliance by all the Headmasters/Headmistresses of concerned Schools.
