MEMORANDUM

Subject : Assignment for Non-practical subjects for Class-X and XII

The outbreak of COVID-19 pandemic and the consequent imposition of prolonged lockdown since 17th March, 2020, has adversely affected the academic activities during the current academic session 2020-21. The Education (School) Department in Tripura has allowed partial re-opening of Schools for the students of Class X and XII w.e.f. 7th December, 2020, recognising the importance of classroom activities/sessions for the students who are preparing for the Board Examination in 2021.

In the annual general meeting of the Governing Body of Tripura Board of Secondary Education, held on 16th December, 2020, the issue of internal marks allotment was discussed in view of the reduced classroom activities/sessions owing to COVID-19 pandemic. It was decided that for each subject not having practicals, a Question-Answer type Assignment shall be prepared by the students of Class-X and XII, from a set of questions taken from the reduced syllabus, with a view to enhance the learning outcome of the students.


The Assignment shall be collected from the students before commencement of the Pre-Board Examinations and shall be as hereunder:

- i) The concerned subject teacher will prepare a list of innovative and creative assignment questionnaires from the reduced syllabus.
- ii) Each question shall carry 5 marks and the Assignment must be prepared within 120-150 words in A4 size paper only.
- iii) The students will prepare any one Question-Answer type Assignment from the set of 10 Questions provided by the concerned teacher.

It may be noted that the marks scored from the assignment will directly allotted to the internal assessment, except for practical-based subjects in H.S.(+2stage), and to be sent to the Board. The students who fail to submit the Assignment within the stipulated period will not be awarded any mark but will be able to appear in the Board Examination.

This will be applicable for the current academic session only.


