
**Sir,**

STANDING ORDER

Subject:-Communication to the print & electronic media by the Secretary-in-Charge of the Department, Govt. of Tripura.

It has come to the notice of the government that some State Government employees are unauthorizedly speaking / communicating to the print & electronic media on officials matters. In this regard attention is drawn to Rule 8 of the Tripura Civil Services (Conduct) Rules, 1988 which prohibits such activities. Further, as per Rule 9 of the said Rules, no public servant can make statement which has the effect of an adverse criticism of any policy or action of the government.

In exercise of power under Rule 23 of the Tripura Civil Services (Conduct) Rules, 1988, it is decided that only the Secretary in charge of Departments to Govt. of Tripura, DGP, PCCF and District Magistrates & Collectors are authorized to speak / brief to the print & electronic media.

Any violation of the aforesaid instructions shall be viewed seriously and action will be taken against the concerned employee as per relevant rules.
