- The approval is based upon the documents/ data/ information uploaded by the schools online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye-Laws-2018.
- 2. The Schools will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The Schools are required to apply on online for extension of affiliation along with the requisite fees and other documents as per Rule 10.3 of Affiliation bye-laws.
- 4. The Schools should go through the provision of Affiliation and Examination Bye-Laws and subsequent amendment therein as well as circulars and guidelines/ instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e. <a href="http://cbseacademic.nic.in">http://cbseacademic.nic.in</a> & <a href="http://cbse/nic/in">http://cbse/nic/in</a> for updates.
- 5. The schools to renew mandatory certificates from time to time.
- 6. The Schools shall communicate with the CBSE Regional Office, Guwahati regarding creation of new e-mail ID of the school which will be used for communication with CBSE only.



- 7. The schools shall not use their names/ logos etc. or engage in any activity which is against policies of CBSE or of Government of Tripura.
- 8. The schools are required to arrange mandatory public disclosure as per Appendix-IX on their websites.
- 9. The schools are required to make available all the necessary information in their websites.

The aforesaid 9 (nine) schools will run under the Directorate of Secondary Education as CBSE affiliated Govt. English Medium schools and strictly follow the CBSE guidelines mentioned above as well as instructions issued from time to time along with CBSE curriculum/ syllabus etc.
