So far as their pension and other retirement benefits are concerned, they will be governed by a new set of Pension Rules, which are being formulated in line with the Contributory Pension Scheme announced by Government of India.

5) The persons concerned are therefore, required to be furnish an undertaking as per specimen enclosed herewith along with their joining report.

6) If any of the candidate fails to join his/her place of posting within the period as mentioned above or in the event of submission of wrong/false certificate/information, the offer of appointment issued in his/her favour shall stand automatically cancelled.

No T.A./D.A. will be allowed for joining the post.
