MEMORANDUM

Sub: Pre-Board Examination- 2021

With the partial re-opening of Schools w.e.f. 7th December, 2020, the classroom activities/sessions for the students of Class X and XII have started with the objective of completion of syllabus (reduced to 70% by TBSE).

The SCERT has notified Weekly Academic Calender for all subjects of class X and XII in order to bring about uniformity and to help complete the syllabus within the time available for classroom activities. The normal classes shall continue up to 31st March, 2021, after which a Pre-Board Examination will be taken as per the new scheme of examination.

The tentative schedule for the Pre-Board Examinations of class X and XII has been fixed from 1st April, 2021 to 20th April, 2021 and the results will be declared on 30th April, 2021.

The Pre-Board Examinations will be conducted at the school level for which questions papers will be prepared and provided by the Centralised Examination Unit of the Directorate of Secondary Education. The evaluation of answer scripts will also be done by the concerned schools. In order to ensure timely declaration of the results of Pre-Board Examinations, the evaluation process shall be started simultaneously as soon as examination has been conducted for any subject. Therefore, schools shall not wait for the entire examinations to be completed in order to start the evaluation of answer scripts.

The allotment of internal marks out of the score obtained in the Pre-Board Examinations shall be as follows:

1. Subjects not having practicals (both for class X and XII) a weightage of 10 marks shall be proportionately allotted out of the marks scored in the Pre-Board Examination.
2. Subjects having practicals in HS (+2 stage) a weightage of 5 marks shall be proportionately allotted out of the marks scored in the Pre-Board Examination.




3. If a student does not appear in the Pre-Board Examination, he/she will not be given any marks for internal assessment against Pre-Board Examination, but will be allowed to appear in the Board Examinations.

While calculating the proportionate marks allotment from Pre-Board Examinations, any decimals shall be converted to the next whole number. For example, if a student score proportionately anywhere between 8.1 to 8.9 she/he shall be allotted 9 marks.

A separate circular will be issued by TBSE in detail on allotment of internal assessment marks which will be applicable for the current academic session (2020-21) only in view of the ongoing COVID-19 pandemic.

This will be applicable for the current academic session only.

This is issued as per decisions taken in the Annual General Meeting of the Governing Body of Tripura Board of Secondary Education held on 16-12-2020.
