Subject:- Providing regular pay scale to the Post Graduate Teachers (Class-XI-XII) appointed on fixed pay basis against the posts created on fixed pay basis by keeping regular pay scale post in abeyance and who have served at the State Government for cumulative period of 05(five) years.

**Whereas,** 35 (thirty-five) Post Graduate Teachers as per list attached as Annexure-A were earlier appointed under the Directorate of Elementary Education, Tripura / Directorate of Secondary Education, Tripura to the post of Graduate Teacher (Elementary/Secondary) w.e.f. the date as recorded in Col. No. 3 on fixed pay basis against the posts created on fixed pay basis by keeping regular pay scale in abeyance in pay band Rs. 5700-24000/-, GP-Rs.2800/- of Level.9 and thereafter they have tendered technical resignation from the posts of Graduate Teacher (Elementary/Secondary) on the date as recorded against each in Col. No. 4 and joined the posts of Post Graduate Teacher (Class-XI-XII) on the date as mentioned against each in Col. No. 5 in pay band Rs. 5700-24000/-, GP-Rs.4200/- of Level.10.

**And whereas,** the Government of Tripura has taken a policy decision for considering the benefit of regular pay scale to the employees who have served the State Government for cumulative period of 5(five) years as fixed pay posts created on fixed pay basis by keeping regular pay scale post in abeyance in different posts in same or different department vide Memorandum No.F.10(2)-FIN(G)/2005(P-1)/47 dated 17th December, 2024 of the Finance Department in partial modification of Finance Department's Memorandum No.F.10(2)-FIN(G)/05/Part-I dated 16th October, 2007.

**And whereas,** the Finance Department vide U.O. No.84/FIN(ESTT.-III)/2025 Dated 28/04/2025 has concurred in the proposal of the Department for providing regular pay scale to 35(thirty-five) nos. Post Graduate Teacher w.e.f. the date as mentioned in Col. No. 6 on completion of their 05(five) years of fixed pay service under fixed pay posts created by keeping regular pay scale post in abeyance by taking into account their cumulating period of fixed pay service in two different posts.

In view of the above the under signed is here by allowed to grant regular pay scale to the aforesaid 35(thirty-five) Post Graduate Teachers as per list attached herewith as Annexure-A w.e.f. the date as mentioned against each in Col. No. 6 along with the other benefits as per rules.

The expenditure involved for this purpose is debitable to the Head of Account against which their fixed pay is being drawn at present. With the grant of regular scale of pay, the fixed pay posts held by the concerned Post Graduate Teacher shall deemed to have been converted into regular posts with regular scale of pay from the date of allowing the benefit. If in the meantime, the employee concerned resigned/terminated from service, this order will not be applicable. If the employee concerned in the meantime transferred elsewhere, this order may be sent to her present place of posting under intimation to this Directorate.

This is issued as per Memorandum vide No. F.10(2)-FIN(G)/2005(P-1)/47 dated 17.12.2024 and in pursuance to the concurrence of the Finance Department, Tripura against U.O. No.84/FIN(ESTT.-III)/2025 Dated 28/04/2025. If any doubt arises in operation of this order, it may be referred to this Directorate for necessary clarification.
