NOTIFICATION

In exercise of the powers conferred by provisions to Article -309 of the Constitution of India, the Governor of Tripura hereby pleased to make the following Rules for the method of recruitment to the post of **School Library Assistant** in the Education (School) Department, Directorate of Secondary Education, Tripura namely: -

1. Short title commencement :-

(g) These rules may be called , "Recruitment Rules 2017" for the post of School Library Assistant under the Education(School) Department.

(h) They shall come into force from the date of their publication in the official Gazette.

2. The name of the post(s) shall be as specified in Column-1 of the Schedule annexed hereto.

3. Number, Classification and scale of pay: -

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule annexed hereto.

4. Method of recruitment, age limit, qualification etc.

The method of recruitment to the said post, age limit, qualification and other matters relating to the said post shall be as specified in Columns 5 to 13 of the said Schedule.

5. Disqualification: - No person-

(g) who has entered into or contracted a marriage with a person having a spouse living; or

(h) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post;

Provided that the State Government may, if satisfied that such marriage is permissible under the Personal law applicable to such person and the other party to the marriage



and that there are other grounds for so doing, exempt any person from the operation of the rule.

6. Power to relax: -


Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing, may relax any of the provisions of these Rules, including age limit, with respect to any class or category of persons.

7. Saving: - Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Serviceman and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

8. Interpretation :-

If any question arises relating to the interpretation of these Rules, it shall refer to Education (School) Department, Government of Tripura, whose decision thereon shall be final.

ANNEXURE-III

Recruitment Rules for the post of **SCHOOL LIBRARY ASSISTANT**, of Education (School) Department, Govt. of Tripura.

SCHEDULE

1. Name of Post :- **School Library Assistant.**
2. Number of Posts :- 1500 (fifteen hundred) plus additional posts as and when created by the Government from time to time
3. Classification :- Group- C Non Gazetted.
4. Scale of Pay :- PB-2 (Rs.5700- 24000/-) plus Grade pay Rs.2800/- as and when revised by the Government from time to time.
5. Method of recruitment whether by direct recruitment or by promotion or transfer on deputation and percentage of the vacancies to be filled by various methods. :- 100% by direct recruitment.
6. Age limit for direct recruitment :-26 - 45 years. Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates or Government Servants.
Provided that in the event of necessity to strengthen the service by experienced personnel, the Govt. may further relax the age.
7. Educational and other qualification required for direct recruitment :- Minimum Graduate Degree from any recognised University with at least 5(five) years teaching experience/handling of books in any Govt./Govt. recognised schools.
8. Whether age and educational qualifications prescribed for direct recruitment will apply in case of promotion. :- Not applicable.
9. Whether Selection Post or Non-Selection post :-Not applicable
10. Period of probation, if any :- 2(two) years.
11. In case of recruitment by promotion/ transfer on deputation, grades from which promotion / transfer on deputation is to be made. :- Not applicable.
12. If a DPC exists, what is its composition. :- Not applicable.
13. Circumstances in which TPSC is to be consulted while making recruitment. :- Not applicable.
