Subject:- Re-allocation of fund in connection with payment of 1st Division in Madhyamik Examination/Re-imburement of Madhyamik Examination fee against TSP (Demand No. - 19) during the year 2017-18.

The Finance Department (Budget Branch) Vide Memo No.**F.40(03)-FIN(B)/2015/39518** dated **05/03/2018** has released a fund of ₹**15,50,000/-** only under **F.R. Code No. 2165** being the Stipend & Scholarship (Non-Salary) during the year 2017-18 under State Plan against **TSP (Demand No. - 19)**.

Now, after careful consideration of the requirement a sum of ₹**2,35,485/- (Rupees two lakhs thirty five thousand four hundred eighty five)** only being the 1st Division in Madhyamik Examination/Re-imburement of Madhyamik Examination fee during the year 2017-18 is hereby re-allocated to the various H/O & D.D.O **West** District under State-Plan against **TSP (Demand No- 19)**.

The amount shall be drawn against the re-allocated fund according to the Delegation of Financial Powers Rules, Tripura 2011 issued vide Notification No.F.9 (2)-FIN (G)/2007 dated 09-12-2011.
