Subject:-Re-allocation of fund in connection with payment of 1st Division in Madhyamik Examination against Own Demand (Demand No. 40) during the year 2017-18.

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2015/39518 dated 05/03/2018 has released a fund of ₹26,00,000/- only under F.R. Code No. 2165 being the Stipend & Scholarship (Non-Salary) during the year 2017-18 under State Plan against Own Demand (Demand No. 40).
