MEMO.

The Government of Tripura vide Notification No.F.1(1)-GA (P&T)/18 dated 02-03-2019 has extended benefits for the family members of deceased Government employees who died on or after the age of 50 years, but before attaining the age of superannuation, by providing the family a special financial benefit termed as "Special Pension" amounting to the difference between last drawn pay and pension, in addition to the family pension, till the deceased employee would have attained 60 years of age, provided that there is no earning member in the family.

- Smt. Dipika Baidya, W/O-Lt. Rabindra Baidya has prayed for Compassionate Benefit(Special Pension) under this Department due to death of her husband Rabindra Baidya died on 28-08-2020 while in service who was a Group-'D'(Night Guard), Rabikumar English Medium H.S School, Mohanpur, West Tripura.
- 3. On scrutiny of the papers/documents/records it is seen that Lt. Rabindra Baidya, Ex-Group-'D' (Night Guard) died while in service after attaining the age of 50 years of age being his date of birth is 01-01-1968. Therefore, Smt. Dipika Baidya, W/O-Lt. Rabindra Baidya is entitled to get "Special Pension" under the "Scheme for Compassionate Appointment / Benefit for Government Employees of Tripura". However, an eligible family member of the family of Lt. Rabindra Baidya is eligible to get "Special Pension" in addition to the family pension till the deceased employee Lt. Rabindra Baidya would have attained 60 years of age as per decision of the Government.
- 4. Now, in consideration of her prayer dated 30-06-2021, Smt. Dipika Baidya, W/O-Lt. Rabindra Baidya "Special Pension" is granted to the family of Lt. Rabindra Baidya in addition to family pension till the deceased employee Lt. Rabindra Baidya would have attained 60 years of age i.e.upto.31-12-2027. The "Special Pension" will be calculated in accordance with the procedure as noted in Para-1 above.
- 5. The Head of Office & D.D.O, Rabikumar English Medium H.S School, Mohanpur, West Tripura is therefore requested to arrange payment of provisional Family Pension alongwith provisional "Special Pension" to Smt. Dipika Baidya, W/O-Lt. Rabindra Baidya, Ex-Group-'D'(Night Guard) and thereafter send proposals for fixation of final pension (Family Pension and Special Pension) to the Accountant General, Tripura.
