Sub:- Grant of regular scale of pay to the Lower Division Clerk recruited on fixed pay basis.

Sarbeswar Debbarma, L.D. Clerk of Khowai Govt. Eng. Med. Class XII School, Khowai, Tripura has been recruited on fixed pay basis vide this Directorate Memo. No.F.1(1-8)SE/E(NG)/2017(L) dated 17/04/2017 against the post created on fixed pay basis Keeping in abeyance of the post on regular pay scale vide Memo No.F.8(1-26) SE/PLAN/2013(79) dated 02/08/2016 with the concurrence of the Finance Department, Government of Tripura Vide U.O.No.F. 107/FIN (Edn. Cell)/2016 dated 22/06/2016.

Accordingly, the employee concerned has joined in service as L.D .Clerk on **20/02/2017 (F/N)** & completed 5 years continuous service & eligible for regular pay scale with effect from **20/02/2022 (F/N)**. The employee concerned name has been also entered in data base of Finance Department against **Sl. No. 24840**. Now, the employee concerned is hereby allowed the regular Scale of pay of **Rs.21,400/- (Twenty one thousand four hundred)** only per month plus other admissible allowance in the level -7 of Tripura State Pay Matrix of 2018 as per Memo of the Finance Department, Govt. of Tripura vide No.F10(2) FIN(G)/05/part-1 dated 16/10/2007.


The expenditure involved for this purpose is debitable to the Head of Account against which the employee concerned fixed pay is being drawn at present.

With the grant of regular scale of pay, the fixed pay post held by Sarbeswar Debbarma, L.D. Clerk shall be deemed to have been converted into regular posts with regular scale of pay from the date of allowing the benefit.

If Sarbeswar Debbarma, L. D. Clerk in the meantime resigned/terminated/expired, this order should be returned to this Directorate.
