04(four) Nos. Graduate Teacher (Class-IX-X) as per list attached herewith as **Annexure-A** under the Directorate of Secondary Education recruited on monthly fixed pay basis with effect from the date of their joining as noted against each in Col.No.3 and who have completed 5(five) years of fixed pay service are hereby allowed regular scale of pay in Level-9 of Tripura Pay Matirx,2018 against PB-2 (Rs.5,700-24,000/-) and Grade Pay of Rs.2800/- plus other admissible allowances per month with effect from the date as indicated against each in Col.No.4.
