Subject:- Re-allocation of fund in connection with payment of Dress-Grant to girls students reading in Class IX & X of Religious Minority Communities for the Academic Year 2019 during the financial year 2018-19 under Revenue head against TSP (Demand No. 19).

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2018/7773 dated 16/03/2019 has released a fund of ₹25,00,000/- only under **F.R. Code No. 2753** being the Stipend & Scholarship (Non-Salary) during the year 2018-19 under Revenue head **against TSP (Demand No. 19)**.

Now, after careful consideration of the requirement a sum of ₹20,000/- (**Rupees twenty thousand**) only being the **Dress-Grant to girls students reading in Class IX & X of Religious Minority Communities Academic Year 2019** during the financial year 2018-19 is hereby re-allocated to the various H/O & D.D.O **North District** under Revenue head **against TSP (Demand No- 19)**.
