Post Graduate Teacher from different Grant-in-Aid Schools i.e. Bishalgarh Class XII School, Bishalgarh, Sepahijala Tripura, Udaipur Ramesh H.S. Accordingly, 03(three) nos. Post Graduate Teacher under Directorate of Secondary Education, Tripura as per list attached in the reverse are hereby withdrawn from their existing Place of posting as noted against each in Col. No. 2 and placed at the schools as noted against each in Col. No. 3 on deputation basis for a period of 02(two) years as substitute of them for pursuing B. Ed. Course 2022-24 as well as for smooth functioning of teaching and learning process of the said Grant-in-Aid Schools.

They should report for their duties at the place of posting and submit joining report to the Head of Office & DDOs, as noted against each in Col. No. 4.

Pay and allowances of the teachers concerned will be drawn and disbursed by the concerned Head of Office & DDOs as mentioned in col. No. 2, after receiving the working report from the Head of Office & DDOs, as noted against each in Col. No. 4 in every month.
