



M E M O R A N D U M

*Subject : Training Incentive under Tripura State Civil Services
(Revised Pay) Rules, 2009 – clarification thereon.*


In Rule-13 under the TSCS (RP) Rules, 2009 Government in the Finance Department, in supersession/ modification of all existing orders; introduced a training incentive with lump-sum grant w.e.f. 01-01-2009 in respect of some categories of employees vide Notification No.F.6(1)-FIN(PC)/2009 dated 05-05-2009 and subsequent Notification of even number dated 06-01-2011.

2. Now, clarification has been sought from some quarters as to whether training incentive would be admissible in the form of one advance increment during period 01-01-1996 to 31-12-2008 in cases of the following employees :

- (i) A concerned employee who had obtained training in the year 1996 and thereafter was appointed on fixed pay basis during period from 01-01-1996 to 31-12-2008 but brought to regular appointment after 31-12-2008;
- (ii) A concerned employee appointed on fixed pay basis on or after 01-01-2006 and obtained training after his appointment to service on fixed pay basis but within 05-05-2009 [date of publication of TSCS (RP) Rules, 2009], and was brought to regular appointment in service after 05-05-2009.

3. After careful examination of all aspects in view, the Governor of Tripura is pleased to clarify that since as per Rule-2(d) of the TSCS (RP) Rules, 2009 fixed pay employees do not come within the domain of the Rules ibid, the question of admissibility of training incentive during fixed

pay period does not arise. However, the employees under reference shall be entitled to get training incentive in the form of lump-sum grant w.e.f. 01-01-2009 or from the date he/ she would be brought to regular appointment in service, if not got the same as per earlier guidelines.


