Subject: - Allowing of benefit of financial up-gradation under **Modified Assured Career Progression Scheme (MACP)** as per TSCS (RP) Rules, 2017.

Pursuant to the provision of Rule-12 of the Tripura State Civil Services (Revised pay) Rules, 2017 the State Government employees under Education Department as mentioned in the annexure enclosed here with are allowed benefit of financial up-gradation as **MACP-3** for completion of 25 years service under the Modified Assured Career Progression Scheme w.e.f. 01-04-2024 with DNI (if any) on 01-01-2025 the date mentioned in col. No. 4 against each in the **Annexure**.

2. There is no scope to exercise option for obtaining MACP benefit from the date of next increment i.e. 01-07-2024 as Finance Department informed that memorandum NO.F.7 (2)- FIN (PC)/2018/592-792 dated 30<sup>th</sup> September, 2023 was issued as one time measure and 'option' could be exercised ( who accrued MACP from 01-04-2017 to 31-10-2023) up to 31-10-2023 only communicated vide Finance Department U.O.NO.96/FIN(Estt-II) dated 27-06-2024.

3. This benefit of financial up-gradation is allowed subject to final verification by the A.G Tripura.
