Subject : - Appointment of Group-D(Class-IV) under the "Scheme for Compassionate Appointment/ Benefit for Government Employees of Tripura" acceptance of joining thereof.

Reference : - This Directorate Memo No.F.1(1-1)-SE/E(NG)-2019(L-3), dated 26.12.2022.

02(two) persons as per list in reverse were given offer of appointments to the post of **Group-D (Class-IV)** in the Secondary Education Department, Tripura vide memo of even number dated 14.12.2022 under the "Scheme for Compassionate Appointment/Benefit for Government Employees of Tripura" and they were directed to join to the School as mentioned against each in Col. No. 4 on **02.01.2023(F/N)**. But the date i.e. **02.01.2023** has been declared as **Govt. Holiday vide Order No. F.4(1)-GA(P)/2023 dated 01.01.2023** due to death of Hon'ble Minister of Revenue, etc. Department. Accordingly, they joined in service to the post of **Group-D(Class-IV)** on **03.01.2023(F/N)**. Now, the joining of the above mentioned 02(two) persons vide this Directorate memo under above reference are hereby accepted as Group-D(Class-IV) under the Directorate of Secondary Education, Tripura on fixed pay of **Rs. 12,000/-(Rupees twelve thousand)** only per month (75% of the pay in LEVEL-1 of the Tripura State Pay Matrix,2018) for a period of 1(one) year with effect from the date of their joining as noted against each in Col. No.5 as per terms and conditions laid down in the offer of appointment.

They are entertained against 2(two) posts as under:-




