## Government of Tripura Directorate of Secondary Education <u>Estt. (N.G) Section.</u> <u>M E M O</u>

The Government of Tripura vide Notification No.F.1(1)-GA (P&T)/18 dated 02-03-2019 has extended benefits for the family members of deceased Government employees who died on or after the age of 50 years, but before attaining the age of superannuation, by providing the family a special financial benefit termed as "Special Pension" amounting to the difference between last drawn pay and pension, in addition to the family pension, till the deceased employee would have attained 60 years of age, provided that there is no earning member in the family.

- 2. Sri Nabarup Bhattacharjee, S/O-Lt. Nabendu Bhattacharya has prayed for "Special Pension" under this Department due to death of his father Lt. Nabendu Bhattacharya died on 21-04-2023 while in service who was an Assistant Headmaster, Raishyabari English Medium H.S School, Ganda Twisa, Dhalai Tripura.
- 3. On scrutiny of the papers/documents/records it is seen that Lt. Nabendu Bhattacharya, Ex-Assistant Headmaster died while in service after attaining the age of 50 years of age being his date of birth is 03-02-1964. Therefore, Sri Nabarup Bhattacharjee, S/O-Lt. Nabendu Bhattacharya is entitled to get "Special Pension" under the "Scheme for Compassionate Appointment / Benefit for Government Employees of Tripura". However, an eligible family member of the family of Lt. Nabendu Bhattacharya is eligible to get "Special Pension" in addition to the family pension till the deceased employee Lt. Nabendu Bhattacharya would have attained 60 years of age as per decision of the Government.
- 4. Now, in consideration of his prayer dated 03-06-2023, Sri Nabarup Bhattacharjee, S/O-Lt. Nabendu Bhattacharya "Special Pension" is granted to the family of Lt. Nabendu Bhattacharya in addition to family pension till the deceased employee Lt. Nabendu Bhattacharya would have attained 60 years of age i.e.upto.29-02-2024. The "Special Pension" will be calculated in accordance with the procedure as noted in Para-1 above.
- 5. The Head of Office & D.D.O, Raishyabari English Medium H.S School, Ganda Twisa, Dhalai Tripura is therefore requested to arrange payment of provisional Family Pension alongwith provisional "Special Pension" to Sri Nabarup Bhattacharjee, S/O-Lt. Nabendu Bhattacharya, Ex-Assistant Headmaster and thereafter send proposals for fixation of final pension(Family Pension and Special Pension) to the Accountant General, Tripura.
