The Government of Tripura vide Notification No.F.1(1)-GA (P&T)/18 dated 02-03-2019 has extended benefits for the family members of deceased Government employees who died on or after the age of 50 years, but before attaining the age of superannuation, by providing the family a special financial benefit termed as "Special Pension" amounting to the difference between last drawn pay and pension, in addition to the family pension, till the deceased employee would have attained 60 years of age, provided that there is no earning member in the family.

- 2. Smt. Sudhan Reang, W/O-Lt. Palendra Reang has prayed for "Special Pension" under this Department due to death of her husband Lt. Palendra Reang died on 25-10-2021 while in service who was a Group-'D'(Helper), Damcherra H.S School, Damcherra, North Tripura.
- 3. On scrutiny of the papers/documents/records it is seen that Lt. Palendra Reang, Ex-Group-'D'(Helper) died while in service after attaining the age of 50 years of age being his date of birth is 02-03-1963. Therefore, Smt. Sudhan Reang, W/O-Lt. Palendra Reang is entitled to get "Special Pension" under the "Scheme for Compassionate Appointment / Benefit for Government Employees of Tripura". However, an eligible family member of the family of Lt. Palendra Reang is eligible to get "Special Pension" in addition to the family pension till the deceased employee Lt. Palendra Reang would have attained 60 years of age as per decision of the Government.
- 4. Now, in consideration of her prayer dated 20-10-2022, Smt. Sudhan Reang, W/O-Lt. Palendra Reang "Special Pension" is granted to the family of Lt. Palendra Reang in addition to family pension till the deceased employee Lt. Palendra Reang would have attained 60 years of age i.e.upto.31-03-2023. The "Special Pension" will be calculated in accordance with the procedure as noted in Para-1 above.
- 5. The Head of Office & D.D.O, Damcherra H.S School, Damcherra, North Tripura is therefore requested to arrange payment of provisional Family Pension alongwith provisional "Special Pension" to Smt. Sudhan Reang, W/O-Lt. Palendra Reang, Ex-Group-'D'(Helper) and thereafter send proposals for fixation of final pension(Family Pension and Special Pension) to the Accountant General, Tripura.
- 6. This is issued as per power delegated vide Memorandum No.F.15(6-41)-SE/GIA/2019 dated 17th February, 2021.
