With a view to ensuring timely deposit of money of Mid-Day-Meal in the bank accounts of nearly 4 lakhs students, timely compilation of exam results, proper distribution of books, preparation of classrooms so that whenever classes are opened for students, social distancing and hygiene norms can be maintained it is hereby ordered that:

- i) All offices under the Directorate of Secondary Education, Elementary Education and SCERT including DEO offices, Inspector of Schools Offices (State & TTAADC) will function in full strength w.e.f. 5th May, 2020.
- ii) With effect from 6th May,2020 all HMs and Teacher-in-Charges should attend schools in order to ensure that Mid-Day-Meal funds are deposited into the bank accounts of students, proper distribution of books to parents is done, maintaining social distancing and proper compilation of results is done for Class- III to IX and XI on the Siksha Darpan App. Besides that any other work as given by field officers is to be ensured. HMs/Teacher-in-Charges may call teachers by rotation whose assistance they require in completion of the above said work.

iii) The above order will not apply to containment zones, as and when declared by the authorities.
