**Subject:- Re-allocation of fund for Stipend & Scholarship Girls Stipend/TMCM during year 2017-18 under state Plan against Own Demand (Demand No. 40).**

The Finance Department (Budget Branch) Vide Memo No.F.40 (03)-FIN (B)/2017/8673-80 dated 25/03/2017 has released a sum of ₹37,50,000/- only under F.R. Code No. 0093 being the Stipend & Scholarship (Non-Salary) during the year 2017-18 (1<sup>st</sup> Quarter) under State-plan against **Own Demand (Demand No. 40).**
