**Subject:- Re-allocation of fund for Dress-Grant to Girls Students of Religious Minority, classes IX to XII Academic Year 2017 during year 2017-18 under state Plan against Own Demand (Demand No. 40).**

The Finance Department (Budget Branch) Vide Memo No.F.40 (03)-FIN (B)/2017/8673-80 dated 25/03/2017 has released a sum of ₹37,50,000/- only under F.R. Code No. 0093 being the Stipend & Scholarship (Non-Salary) during the year 2017-18 (1<sup>st</sup> Quarter) under State-plan against **Own Demand (Demand No. 40)**.

Now, after careful consideration of the requirement a sum of ₹5,84,000/- (**Rupees five lakhs eighty four thousand**) only being the Dress Grant to Girls Students of Religious Minority classes IX to XII **Academic Year 2017** during the year 2017-18 is hereby re-allocated to the various H/O & D.D.O **Unakoti/West** District under State-Plan against **Own Demand (Demand No. 40)**.

The amount shall be drawn against the re-allocated fund according to the Delegation of Financial Powers Rules, Tripura 2011 issued vide Notification No.F.9 (2)-FIN (G)/2007 dated 09-12-2011.

This re-allocation is issued in pursuance of fund released from the Finance Department vide Memo No. F.40 (03)-FIN (B)/2017/8673-80 dated 25/03/2017 under F.R. Code No. 0093 appropriation as follows:-
