Subject:- Re-allocation of fund for Dress-Grant to Girls Students of Religious Minority, classes IX to XII Academic Year 2018 during year 2018-19.

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2015/1154 dated 21/05/2018 has released a fund of ₹24,00,000/- only under **F.R. Code No. 0500** being the Stipend & Scholarship (Non-Salary) during the year 2018-19 **against TSP (Demand No. 19).**

Now, after careful consideration of the requirement a sum of ₹3,42,000/- (**Rupees three lakhs forty two thousand**) only being the Dress Grant to Girls Students of Religious Minority classes IX to XII **Academic Year 2018** during the year 2018-19 is hereby re-allocated to the various H/O & D.D.O **South/Unakoti/Sepahijala/Gomati/ West/Dhalai** District against **TSP (Demand No. 19).**

The amount shall be drawn against the re-allocated fund according to the Delegation of Financial Powers Rules, Tripura 2011 issued vide Notification No.F.9 (2)-FIN (G)/2007 dated 09-12-2011.

This re-allocation is issued in pursuance of fund released from the Finance Department vide Memo No.F.40(03)-FIN(B)/2015/1154 dated 21/05/2018 under F.R. Code No. **0500 Demand No. 19** with appropriation as follows:-
