Subject:-Re-allocation of fund for providing free text books (Non-Salary) to the students reading in the Classes-IX & X holding BPL cards or belonging to BPL family/BPL listed for the academic year 2018 financial year 2018-19 under revenue head against Demand no. 40 .

The Finance Department (Budget Branch) Vide Memo No.F.40 (01)-FIN (B)/2018/5293 dated 25/10/2018 has released a sum of ₹10,00,000/- only under F.R. Code No. 1643 being the cost of free text books to BPL students (Non-Salary) or BPL listed students during the year 2018-19 under revenue head against own Demand (Demand No. 40).

Now, after careful consideration of the requirement a sum of ₹10,00,000/- (**Rupees ten lakhs**) only being the cost of **free text books to the students reading in the classes IX & X** holding of BPL cards or belonging to BPL family (listed) during Academic Session 2018 is hereby re-allocated to the various H/O & DDO, **Unakoti** District under revenue head against own Demand(Demand No. 40) financial year 2018-19.

The amount may be drawn against the re-allocated fund according to the Delegation of Financial Powers Rules, Tripura 2017 issued vide Notification No.F.9 (2)-FIN (G)/2017 dated 25-08-2017.

This re-allocation is issued in pursuance of fund released from the Finance Department vide Memo No. F.40 (01)-FIN (B)/2018/5293 dated 25/10/2018 under F.R. Code No. 1643 with appropriation as follows:-
