Subject:- Re-allocation of fund for Dress-Grant to Girls Students of Religious Minority, classes IX to XII Academic Year 2017 during year 2017-18 under state Plan against Own Demand (Demand No. 40).

The Finance Department (Budget Branch) Vide Memo No.F.40 (03)-FIN (B)/2017/8673-80 dated 25/03/2017 has released a sum of **₹37,50,000/-** only under F.R. Code No. 0093 being the Stipend & Scholarship (Non-Salary) during the year 2017-18 (1st Quarter) under State-plan against **Own Demand (Demand No. 40)**.

Now, after careful consideration of the requirement a sum of **₹1,24,000/- (Rupees one lakh twenty four thousand)** only being the Dress Grant to Girls Students of Religious Minority classes IX to XII **Academic Year 2017** during the year 2017-18 is hereby re-allocated to the various H/O & D.D.O **Dhalai District** under State-Plan against **Own Demand (Demand No. 40)**.

The amount shall be drawn against the re-allocated fund according to the Delegation of Financial Powers Rules, Tripura 2011 issued vide Notification No.F.9 (2)-FIN (G)/2007- dated 09-12-2011.
