Subject:- Re-allocation of fund in connection with payment of Re-imburement of Madhyamik Examination fee during the year 2018-19 under Revenue head against TSP (Demand No. 19).

The Finance Department (Budget Branch) Vide Memo No.F.40(01)-FIN(B)/2018/6430 dated 29/12/2018 has released a fund of ₹16,00,000/- only under **F.R. Code No. 2112** being the Stipend & Scholarship (Non-Salary) during the year 2018-19 under Revenue head **against TSP (Demand No. 19)**.
