Subject:- Re-allocation of fund in connection with payment of Girls Stipend/TMCM to the students reading in Class XI & XII during the financial year 2018-19 under Revenue head against TSP (Demand No. 19).

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2018/7773 dated 16/03/2019 has released a fund of ₹25,00,000/- only under **F.R. Code No. 2753** being the Stipend & Scholarship (Non-Salary) during the year 2018-19 under Revenue head **against TSP (Demand No. 19)**.

Now, after careful consideration of the requirement a sum of ₹15,25,900/- (**Rupees fifteen lakhs twenty five thousand nine hundred**) only being the Girls Stipend/TMCM to the students reading in class XI & XII during the financial year 2018-19 is hereby re-allocated to the various H/O & D.D.O **West/Sepahijala/Unakoti/Gomati/South/Khowai** District under Revenue head against **TSP (Demand No- 19)**.

The amount may be drawn against the re-allocated fund according to the Delegation of Financial Powers Rules, Tripura 2017 issued vide Notification No.F.9 (2)-FIN (G)/2017 dated 25-08-2017.

This re-allocation is issued in pursuance of fund released from the Finance Department vide Memo No. F. 40(03)-FIN (B) /2018/7773 dated 16/03/2019 under F.R. **Code No. 2753 Demand No. 19** with appropriation as follows:-
