Subject:- Re-allocation of fund for- Re-imburement of Madhyamik Examination fee to the various DDO(s) during the year 2019-20 under Revenue head against SCP (Demand No. 20).

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2015/16965 dated 22/10/2019 has released a fund of ₹8,00,000/- only under **F.R. Code No.2089** being the Stipend & Scholarship (Non-Salary) during the financial year 2019-20 under Revenue Head, **against SCP (Demand No. 20).**
